**FREESTYLE TERRAIN**

Granite Peak promotes the Smart Style program and uses the Orange Oval to designate Freestyle Terrain, that will feature things like jumps, rails, boxes, and other constructed features. Prior to using Freestyle Terrain, you are responsible for familiarizing yourself with Freestyle Terrain and obeying all instructions, warnings, and signs. Freestyle skills require maintaining control on the ground and in the air.

- WARNING – DUTIES OF INDIVIDUALS ENGAGED IN SKIING:**
- Under Wisconsin law, each individual engaged in skiing has a duty to do all of the following:
1. Obey all posted warnings and signs.
  2. Keep off closed trails and out of closed areas.
  3. Know the range of his/her/their ability and engage in skiing within that ability.
  4. Assess the difficulty of the trails and terrain that are open to skiing.
  5. Maintain control of his or her speed and direction.
  6. Be able to stop or avoid other individuals or objects.
  7. Yield to other individuals engaged in skiing who are ahead or who are down the slope.
  8. Do not stop at a point that will result in the individual obstructing a trail or not being visible from above.
  9. Yield to other individuals engaged in skiing who are uphill when starting downhill or when merging onto a trail.
  10. Be able to safely board, ride, and dismount any lift serving an area open to skiing.
  11. Board and dismount a lift only at designated sites.

**ASSUMPTION OF RISK:** You assume the risks of skiing and snowboarding. Skiing and snowboarding in its various forms and riding lifts are hazardous activities that involve the risk of serious injury or death. Each trail is unique and conditions change with skier use, weather and other factors resulting in bare spots, ice, variations in snow, bumps, ruts, exposed rocks, moguls, stumps, and other hazards. Natural and human-made hazards, whether marked or unmarked, are common on or near ski trails including rocks, trees, stumps, logs, bushes, sticks, debris, snowmaking equipment, steel pipes, poles, fencing, fence posts, stakes, hoses, wires, cables, lift towers, and other hard obstacles, as well as snowcats, snowmobiles, four-wheelers, cars,

trucks, and other vehicles. Falls and collisions do occur and injuries may result. By purchasing a lift ticket and choosing to ski or snowboard at Granite Peak, you are assuming the risks and dangers of skiing and the burden of skiing or snowboarding under control at all times. If you do not want to assume these risks, you should not ski at Granite Peak.

**WISCONSIN LAW PROVIDES:** "WARNING – ASSUMPTION OF RISKS: Under Wisconsin law, each participant in an alpine sport is considered to have accepted and to have knowledge of the risk of injury or death to person or injury to property that may result. Under Wisconsin law, each participant in an alpine sport

has the duty to take the precautions that are necessary to avoid injury or death to person or injury to property. Wisconsin law sets forth certain other limitations on the liability of ski area operators for injuries or death to person or injury to property. A complete copy of this law is available for review at the main site where tickets to this ski area are sold."

**TRAIL DESIGNATION:** Skiers and snowboarders should be advised that trails designated by a green circle, blue square, black diamond, double black diamond, or an orange oval at Granite Peak are not necessarily the same or similar difficulty level at a trail rated the same at another ski resort. The system and the markings are

relative to the terrain at Granite Peak only. Skiers and riders should work their way up, beginning with easier trails no matter what their ability level may be, until they are familiar with the trails at Granite Peak.

**DRONE POLICY:** Due to safety concerns, Granite Peak Ski Area prohibits the use of drones on or above the ski areas. This prohibition includes drones used for filming or videotaping and extends to drones launched or operated from Granite Peak, as well as those launched from outside the Granite Peak boundaries. Violation of this policy may involve suspension of your access privileges to Granite Peak or revocation of your season pass.
