***Off Trail Policy**

Wooded areas beyond the marked ski resort area boundary as shown on this trail map are closed to skiing and snowboarding. Woods between open trails are not marked trails, are not patrolled and have no skier/snowboarder services. If you decide to ski or snowboard inside the ski resort area boundary, enter from and exit to an open trail. If you ski or snowboard in these wooded areas, you are solely responsible for yourself. You should be an expert skier or snowboarder, and you should stay in groups of three or more. If you ski or snowboard beyond the ski resort area boundary, Vermont Law provides that you are liable for all expenses for search and rescue services.

Do not ski or snowboard on or across closed trails.

Uphill Travel Policy

Uphill traffic is allowed during specific times and areas. No uphill traffic is allowed during operational hours. Please visit smuggs.com/uphilltravel for the complete Uphill Travel policy.

SKI TICKET CONTRACT, EXPRESS ASSUMPTION
OF RISK AND FORUM SELECTION AGREEMENT

Please Read Carefully. I understand and VOLUNTARILY accept that accidents and injuries occur at ski areas and that many obstacles and hazards exist and they may or may not be seen. I agree, as a condition of being allowed to use the ski area premises and facility, that I freely accept, voluntarily and expressly assume ALL RISK OF PERSONAL INJURY OR DEATH OR PROPERTY DAMAGE and I hereby agree not to make any claims against SMUGGLERS' NOTCH MANAGEMENT CO. LTD., D/B/A SMUGGLERS' NOTCH RESORT, its agents, employees, directors and officers for personal injury or death or property damage which results in any way from: "inherent risks" of participating in winter sports, conditions on or about the premises and facilities, the operation of the ski area including but not limited to grooming, snowmaking, other ski area operations, natural and man-made obstacles or their placement, visibility or condition, acts or omissions of employees or agents of the area, or my participation in any form of skiing or any other activities at the area, accepting myself the full responsibility for any such damage or injury of any kind which may result.

I further agree that the phrase "inherent risks" means those risks which are listed in this agreement, or those that can reasonably be inferred therefrom. I also agree that these risks are both obvious and necessary to these winter sports activities. I agree that these inherent risks include but are not limited to changing weather conditions; surface and/or subsurface snow conditions as they may from time to time exist and may change or be affected by weather; skier or other participant usage (whether such condition is surface or subsurface or consist of ice, hard pack, powder, packed powder, wind pack, corn, crust, slush, cut, up snow, and/or machine made or machine enhanced snow); other conditions including bare spots, forest growth and debris, stumps and trees, stream beds and other natural objects and/or collisions with such objects; collisions with lift towers, signs, posts, fences or other enclosures, water and/or air pipes or other man-made structures, and/or their components such as hydrants used in snowmaking or for other necessary purposes, whether or not these structures are padded or shielded; collisions with well marked or plainly visible snowmobiles, snow grooming, or other over-snow vehicles or equipment; variations in steepness of terrain including but not limited to roads and/or other terrain modifications or variations in terrain that occur naturally or as the result of slope design, weather changes, snowmaking and/or snow grooming operations, or participant usage.

I further agree THAT THE TERMS OF THIS AGREEMENT WILL BE BINDING AND THAT ANY DISPUTE ARISING OUT OF THIS CONTRACT AND/OR ANY USE BY ME OF ANY OF THE PREMISES OR FACILITIES OF SMUGGLERS' NOTCH MANAGEMENT CO. LTD., D/B/A SMUGGLERS' NOTCH RESORT, its agents, employees, directors and officers, shall be LITIGATED EXCLUSIVELY IN THE SUPERIOR COURT OF LAMOLLOU COUNTY, VERMONT OR US DISTRICT COURT OF VERMONT and that no claims or actions shall be brought in any other jurisdiction. If I am signing on behalf of a minor, I hereby certify that I have the full authority to act as his/her legal guardian and in the capacity, I hereby agree to fully indemnify and hold SMUGGLERS' NOTCH MANAGEMENT CO. LTD., D/B/A SMUGGLERS' NOTCH RESORT, harmless from any and all damages or losses or claim or action of any kind brought by any person, including the minor, which arises out of the use by the minor of any SMUGGLERS' NOTCH MANAGEMENT CO. LTD., D/B/A SMUGGLERS' NOTCH RESORT premises or facilities.

I further understand that this is a contract that limits my legal rights, and it shall be binding upon me, my heirs, next of kin, executors and administrators. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect. AS A CONDITION OF BEING ALLOWED TO USE THE FACILITIES I HAVE READ, UNDERSTAND, AND AGREE WITH THE MOUNTAIN PRIVILEGES AGREEMENT AND THE SKI CONTRACT, FORUM SELECTION AGREEMENT, ACKNOWLEDGMENT AND EXPRESS ASSUMPTION OF RISK.
